- Learn practices, procedures, methods and materials involved in the installation, cleaning maintenance and repair of water and sewer system, valves, pipes fittings, fire hydrants, and related infrastructure.

- Work cooperatively with others.
- Prepare and compile routine records related to work performed.

#### EXPERIENCE:

- Minimum of one (1) year general maintenance experience

#### OTHER REQUIREMENTS:

- Must have and maintain a valid state driver's license

- Must have no misuse or abuse of alcohol or other mind altering chemicals for a period of one (1) year prior to employment or while employed.

#### PHYSICAL CHARACTERISTICS AND/OR PREREQUISITES:

- Dexterity of hands and fingers to operate a variety of equipment.
- Sitting and standing for extended periods of time.
- Lifting, carrying, pushing or pulling heavy objects as assigned by the position.
- Bending at the waist, stooping, kneeling or crouching.
- Reaching overhead, above the shoulders and horizontally.
- Seeing to operate equipment and read a variety of materials.
- Hearing and speaking to exchange information.
- Climbing ladders.
- Heavy physical labor.

#### SPECIFIC JOB PERFORMED:

- Assist a variety of duties related to the operation, maintenance and repair of Quil Ceda Village water and wastewater systems, facilities and related equipment.
- Inspect water and wastewater equipment and systems including valves, blowers, mixers, pumps, motors, tanks and gauges; diagnose and assist with the repair of mechanical and electrical malfunctions; replace system components as needed; wash tanks of sewer pipe galleries.
- Assist with inspecting and cleaning water and sewer lines; flush and remove obstructions from sewer lines; repair or replace valves, control devices, pipes, fittings and various other fixtures, parts and equipment; assist with installing, maintaining and repairing fire hydrants and manholes as required.

- Respond to water and sewer emergencies as needed; participate in clean-up activities after major storms.
- Prepare and compile various records related to sewer and water systems, chemicals, cleaning, maintenance, fire hydrants, meter readings, inventory and assigned activities.
- Assist with the application of chlorine and other water treatment related chemicals to adjust water quality as required; monitor and record meter readings of water consumption levels.
- Maintain facilities in a clean and sanitary condition; pressure wash and steam clean equipment.
- Read residential and commercial water meters and record volume used for billing purposes as assigned; inspect meters and connections and perform repairs and replacements as needed.
- Maintain various records related to water testing and system monitoring.
- Perform related duties as assigned.

### TERMS OF EMPLOYMENT:

This Regular Full-time position requires at least 40 hours per week or 2080 hours per year. Employees may be required to work after hours on weekends, at special events, or on call. Upon completing the applicable probationary period, an employee may be eligible for a pay increase, subject to budgetary restrictions. Employees will be required to work on-site, with no telecommuting. No provisions for relocation will be provided.
