- Must be able to lift, carry, push and pull up to 75 pounds.
- Stamina & mobility to sit or stand for prolonged periods of time, to bend, kneel, crouch, reach overhead, above the shoulders and horizontally stoop, and/or climb stairs and to walk in a variety of terrain.

### SPECIFIC JOB PERFORMED:

- All of these items require manual labor which may include digging ditches, lifting and other labor intensive tasks
- Performs maintenance on Quil Ceda Village roadways.
- Loads and hauls equipment on trailer from job site to job site.
- Maintains equipment on a daily basis by checking hydraulic lines and greasing as necessary (follow equipment manuals).
- Maintains the equipment with use of proper safety equipment and procedure by employee.
- Required to operate light and heavy equipment including but not limited to a tractor w/ implements, excavator and tractor other equipment rented or owned by QCV.
- Secures tools and machinery on a daily basis.
- Uses shovel and hand tools on a daily basis to assist with trenching, excavating and brush cutting.
- Performs other job related duties as required or directed.

#### TERMS OF EMPLOYMENT:

This is a Regular Full-time position, requiring at least 40 hours per week, or 2080 hours per year. Employee may be required to work after hours, weekends, special events and/or on call. Upon successful completion applicable probationary period employee may be eligible for an increase in pay, subject to budgetary restriction. Employees will be required to work on-site, no telecommuting. No provisions for relocation will be provided.
