Public Safety & Justice

3) Tulalip Police Department

Overview provided by Chief Chris Sutter

Last month there was a hit and run and we were asked to follow-up with the Council. The incident occurred in the Walmart parking lot, and the video coverage did not capture a vehicle license plate. Another hit and run occurred on 88th and that one fled the scene, and lastly one the roundabout by the outlets. This report will be sent to the Council when time allows. The Council asked Chief Sutter where they get the most calls for service. He responds, officers are spending the most time at The Seattle Premium Outlets, The Tulalip Casino, Walmart, and the Home Depot calls are on a steady decline, we get the least calls from Cabela's. TPD has regular meetings with SPO to help provide safety tips and get feedback to provide better service. The Council asked Chief Sutter to continue to gather data to improve public safety within the Village.

4) Marysville Fire District April Report

Discussion: Chief Martin McFalls, Martin Napeahi, General Manager

In April of this year, Marysville Fire District responded to total of 37 calls in the village and 34 EMS related. Our response time is up by 35 seconds, now the total average response time is 8 minutes 02 seconds. Calls for services is down by 10 calls from this time last year. In other news, we were running a ballot initiative that was certified on May 3, 2019. That will go into effect January 1, 2020. The measure was to help fund a Regional Fire Authority, RFA, and assist with funding wages and equipment costs, along with grant funding. The RFA inter-local agreement to provide service to growing area of Marysville and Arlington. We recently conducted an emergency management training at the Seattle Premium Outlets, complete with props, guns, makeup to simulate injuries. We learned a lot during this training and will continue the trainings to improve response times and preparedness. The Marysville Fire District applied for a grant to be used for ballistic protection, as calls for service can be dangerous. The Council asked what local agencies participated in the training. Chief McFalls responds, it was Seattle Premium Outlets staff, Tulalip Police Department, Marysville Fire District.

12) sUAS April Flights

During the month of April there were twelve (12) sUAS flights conducted by TDS. The purpose of the flights was to gather and collected video and photos of the Gathering Hall, Marina, QCC Casino sites, the Swanson Property and Demberritt property. The Council asks if they do regular flyovers to collect data on known homeless camps. TDS does collect that specific data when TPD asks, and they also looked into infrared cameras to conduct those flights. The cost of those were outrageous, so they will continue to use their current ones.

We are showing slightly under budget, but only because we have made the annual public safety payments yet. We typically do that at the beginning of the third quarter. Once those are paid, we'll be on pace. The revenue is down due to declining cigarette sales. For projects, we are working on integrating the new software system at The Tulalip Liquor Store. With the software change, we will need to upgrade the point of sales registers. That upgrade prompted us to look at our cameras, so those will also be upgraded. We will come forward with authorization to purchase when we're ready to complete those security upgrades.
