Chief McFalls provided an overview of statistic for services provided within the District 12 and Tulalip/Quil Ceda Village area. November 1, 2016 the City of Marysville, City of Arlington, and District 12 had a meeting to formulate a plan for a joint venture fire response team. Our team will work to present this joint venture to

voters in 2017, and at the latest 2018. Combining our current agencies will expand services to the area, improve response times, and improve efficiency. We will continue to work with Tulalip Tribes and Quil Ceda Village as we move forward.
