12) 116th Street Interchange Project Update

As of May 1st, project is about 59% complete. Tribal Member subcontractor participation spreadsheet was passed out to Council. Landscaping will is being removed from this phase because the new ramps will just tear it back out. TERO participation is lower than expected. Contractor has been training some of the young TERO participants above the expectation in the contract. The Boom City site will be vacated by the end of May so it will not interfere with the Boom City move in. The Tribes will not own the overpass but will own the infrastructure in the bridge. Memorial weekend will have some congestion with plating the ramp which is needed to pull the conduits.
