Army Corps wants assurance on future development and protection of existing wetlands. MOU between QCV, TTT, EPA and Army Corps of Engineers. This is a relatively new program and the first of its kind in Washington State. Attorneys will recommend if it is an MOU or MOA. Conceptual plan has been submitted for an area of approximately 1500 acres with approximately 400 acres for development since October 2009. The discussion between the agencies is moving slowly. This is an FYI to the Village Council as this has been in process for two years. A strategies session with the Tulalip Board of Directors should occur to further discuss these issues.
