**Marysville Fire District 12**

4) Update on progress for new agreement between Quil Ceda Village and Marysville Fire District 12 to provide fire and emergency medical services.

Discussion: Glen Gobin, John McCoy, Steve Gobin, Tony Hatch, Patti Gobin, Marlin Fryberg, Jr., Chief Greg Corn provided a detailed power point to the Council on the Marysville Fire District including boundaries, calls for service and budget. The formula for the calculations needs to be reassessed. There is no formula for tribal lands. We need to work on a formula that is comfortable for the Tribe. We need to create a team for further discussions. The Council would like the Consultants to review the portion of taxes that is collected and the separation on property taxes from the construction based tax. Staff would like to consider a unit price for the call for services from Fire District 12 within Quil Ceda Village. The strategic funding for the fire station was re-allocated by the Tulalip Board of Directors in 2004. The decision was made to wait on building a fire station within Quil Ceda Village. The consultants will bring back information on the costs to build a fire station and staff it. How does the district put a budget together? Some districts can provide more services than other. Some districts really struggle to provide basic services. How do districts decide to charge for services or events? What happens to those who can't pay? Are services still provided? Some districts require payment for stand-by services for events. This discussion is about QCV. Can district boundaries be expanded? Staff and the Consultant team have gathered a great deal of this information. They are reviewing it and will come back with a recommendation for the Council. The Council will be meeting with the City of Marysville and Fire District 12 Commissioners to negotiate the new contract for Fire and E.M.S. services within the Village.

**Law Enforcement**

5) Police Report

The concert season was very busy for the police department. There were not any incidences. The second week of August was very busy with the Boys & Girls Club 3-on-3 tournament, Summer Jubilee, Back to School kickoff at the Outlets, Saturday Market, and the Beach Boys Concert. The officers provided traffic control. Staff has been working with Border Patrol on the issues for Tribal members passing through Canadian waters to participate in the annual canoe journey. Our Tribal officers may, in the future, be allowed to become cross-deputized to work along with the Border patrol. There were 264 stops. The concealed weapons permit is something that the Council along with the Tulalip Board of Directors needs to further discuss. The attorney said that there was a Resolution passed for concealed weapons. Legal will research the Ordinance and bring it back to the Village Council.

**Finance**

This policy sets guidelines for Quil Ceda Village staff. There have been a number of issues with Tribal property and it is unclear in the HRO 84. This document will be a mechanism to clearly communicate the responsibilities of staff who receive cell phones. It may need to be amended from time to time and technology changes. Legal has reviewed the policy and worked with staff to create the document.

- 8) Solid Waste Franchise Ordinance

FYI-Budget Fees (6% of Gross Revenue)

The fees that would be collected are sufficient to offset the costs to implement and manage the Solid Waste Franchise Ordinance. Are there restrictions on how the money is to be used? It is to be used by the Utilities department to pay the expenses for garbage collection and compliance within the Village. It will go into the Utility department general fund. If further restrictions are necessary to define the use of the revenue, that could be done at a later date. This is the initial trial period for the Utility department.

The Village will get 6% of the gross revenue.

A summary was provided per the Council's request. The open claims cost are time loss and medical bills. They come from the workers' comp fund that was set up by the Tribe to cover these costs. The Council would like more detailed information on the type of injuries and what prevention is being done to reduce the risk of those injuries.
