3) Police Report

August 1, 2008-September 1, 2008 Monthly Report-Written report provided to Council

Discussion: TTT Chief Smith, Glen Gobin, Steve Gobin, Mac McKinsey, John McCoy, Patti Gobin, Debbie Bray, Stan Jones, Sr.

Law Enforcement responded to 251 calls for this month. This is about 150 calls less than the same time last year. There were 18 motor vehicle accidents. Have we had any thought of changing the route for traffic to 27th? We would need to place officers at the light on QC Blvd. to control traffic and lights. Would we need to also place officer at Wal-Mart? Yes. We should meet on this and plan. Chelsea should also participate with the cost. We need to control and not monitor. The State Patrol should also attend the meeting with QCV and TTT Police for the holiday schedule. The money left in the budget is recommended by the General Manager to stay in the account to pay for cost of Black Friday. Two officers will graduate within the next week. TTT Police will also start training all police. \$10,000 will be spent on tasers, \$6,000 for uniforms. This has been approved by the Board of Directors. We need a minimum of 5 officers for the Village. TTT Police and Economic Development staff had a meeting on accidents. The form Law Enforcement currently uses does not sufficiently report accidents. Law Enforcement will begin using the State form now so that the accidents can be properly reported. The State Patrol currently is able to scan an individual's driver's license. Will our officers be able to do this? The Tribe does not have the technology. It is critical for this information for the Tribe so that we can target and assist problem sites. The research/report done by staff will allow staff to find the causes and solutions in the traffic situation. This issue needs a resolution. We need software that can assist us with traffic solutions. We need a joint task force with the State. We requested a grant for traffic officers and are waiting for an answer. We need to make sure that the grants are followed to ensure the safety of our community. We need to hire a person to input the data. We would need to hire a full time person to input old data and get caught up, and then the person could be PT.
