SPECIFIC JOB PERFORMED:

- Clean and sanitize restrooms and shower using established practices and procedures; refill restroom dispensers
- Clean, dust, and wipe surfaces and furniture; sweeps; mops, scrubs surface floors and vacuums hallways, stairs, meeting rooms and office space carpets.
- Empty trash and garbage containers throughout the interior and exterior each day into garbage & recycle containers as needed to maintain a clean & healthy environment.
- Wash accessible interior windows, clean blinds, launder cleaning rags, dust mops, and towels.
- Maintain inventory of cleaning supplies and replenish stock as needed.
- Move furniture, equipment, supplies and tools on an occasional basis as needed or requested.
- Clean staff lounge/kitchenette areas as needed to maintain a clean and healthy environment including food service equipment such as ice machine, hot drink dispensers, coffee makers, stove, refrigerator, microwaves, etc.
- Clean countertops and sinks daily or as needed to maintain a clean and healthy environment.
- Inspect for damage on building, parking lot or walkway due to acts of nature or vandalism.
- Perform minor building maintenance such as HVAC, plumbing, electrical, drywall, painting and other repairs as needed. (such as replacing air filters quarterly)

- Perform general labor and ground maintenance tasks such as picking up debris, cleaning gutters and drains, washing outside windows, and weed eating.
- Perform outside cleaning and related activities such as removing snow or debris from sidewalks and stairs in areas within the buildings using hand operated tools or small power equipment.
- Take classes as required in cleaning methods and techniques, new products, first aid, CPR, and working relationships; attend to emergencies when necessary, attend safety meetings and other related meetings.
- Perform other related duties as needed.

TERMS OF EMPLOYMENT:

This is a Regular Full-time position, requiring at least 40 hours per week, or 2080 hours per year. Employee may be required to work after hours, weekends, special events and/or on call. Upon successful completion applicable probationary period employee may be eligible for an increase in pay, subject to budgetary restriction. Employees will be required to work on-site, no telecommuting. No provisions for relocation will be provided.
