4) Tulalip Fire District Monthly Report

5) Tulalip Police Department Monthly Report

Chief Ledford reported a decrease in monthly call volume, with 1,369 calls compared to the usual 2,000. Key areas of activity included Quil Ceda Village (32%), Quil Ceda Creek (21%), and Tulalip Gaming Organization (38%). There were five domestic violence incidents, 25 shoplifting cases, and a notable number of drug-related calls, primarily in QCC (50%) and the Village (37%). Trespass and traffic enforcement remain active, with 298 traffic stops and one vehicle theft reported. The department is shifting focus toward housing and increased presence on the reservation. Facial recognition technology is being considered to help identify and exclude non-tribal individuals involved in drug activity, with training and implementation discussions underway. Surveillance efforts include eight cameras, one currently offline, and use of Flock alerts for stolen vehicles. President Parker requested that the facial recognition proposal be reviewed by the Service Committee.

#### 6) License Plate Discussion - Addition

Council Member Shopbell inquired about the possibility of issuing tribal license plates to support tribal sovereignty. General Manager Jones shared that the team has researched several options and will provide an update at the next council meeting. Jennifer Flores confirmed that tribal plates, such as those from the Yakama Nation, are recognized in Washington State, and noted that a formal resolution would be needed to allocate staff time for further development. Discussion included the need for a state compact to ensure recognition of tribal plates, and the potential creation of a new tribal department to manage the program. Council Member Shopbell expressed support for establishing the service in the new building and emphasized its long-term value for tribal identity and infrastructure. A motion was made by President Parker to form a project team to research the initiative, with QCV staff leading the effort.

#### 7) Administration Building Discussion

General Manager Jones shared that department-level meetings have been held to review details for the new admin building, but further discussion is needed to finalize plans. Two potential sites are being considered, with the larger location down the road currently favored. Council members and leadership expressed interest in incorporating tribal vendors, a coffee shop, and possibly a visitor center to promote Tulalip-made goods and support economic development. Parking limitations and tenant recruitment were noted as challenges. If the current site is selected, some staff may temporarily relocate to TDS or work remotely for 18–24 months. Council Member Shopbell emphasized the importance of new business opportunities and a growing population, while President Parker and others supported partnering with Hibulb for a gift shop and creating space for talented tribal members to sell their work.

Deputy Chief Ryan White explained that Tulalip Fire District No. 15 has requested the removal of Section 7.7 regarding reimbursements and asked that the Fire Department retain transport revenues. General Manager Jones noted that mid-year financial adjustments have not yet occurred, so cost increases are still unconfirmed. Ryan offered to provide supporting data, and it was clarified that the Fire Department operates under a separate budget, scheduled for review by the Services Committee on the 29th. The department has a fixed service contract for the next eight years. Council Member Shopbell voiced support for continued funding, citing service gaps in Marysville. Transport billing is handled through an outside company, with estimated revenues between

\$80,000-\$90,000. President Parker asked about budget alignment, and Village Clerk Flores confirmed tribal recognition would require a formal resolution.
