Staff is presenting an amendment to the tax code. The proposed increase is 8.5% referencing the surrounding jurisdiction. Why did the tribe start the tax different from the State? This was brought up at the last meeting. The retro portion is to October 2005.

Motion made by Les Parks to amend the Quil Ceda Village tax code as follows to section 11.2 Rate of Tax. The Rate of Tax levied and imposed by Section 11.1 shall be equal to the Sales or Use tax collected by the State of Washington, including amounts collected by the State and distributed to other jurisdictions, on each sale made or item used within the City of Marysville, Washington.

Questions: The language of the amendment states whatever Marysville imposes will be the rate that Tulalip charges. With this wording, do we want to word the amendment for Marysville? Staff presented and gave a summary presentation for the budget for the next 5 years. This is an update and a request for approval for a stream course for Coho Creek. The budget information is provided in the QCV Council meeting packet. Council has questions on the affluent water and its use. Staff has spoken with consultants for the permit process. When the process started, staff spoke with ecology and EPA. Are the 2006 projected amounts in the budget? The money will need to be placed in the allocation fund. Staff will look at applying for grants. There needs to be some sort of coordination with the county clean up crew and staff for maintenance of the ditches. The clean up crew needs to be aware of the spawning channels. The BOD and the Village can coordinate the communication with the county.

8. Review draft Solid Waste Collection Franchise Tax/Fee.

Discussion: John McCoy, Glen Gobin, Les Parks, Peter Mills, Mike Taylor, Chuck James

Staff recommends that the fee be imposed by the Village and the Tribe. Council is requesting a report on the fees. Currently in the leases there is not a charge for the tax/fee. The fee will be imposed on the business that collects the solid waste. In the QCV code the highest amount charged would be 6%. This document is for QCV and the company to providing solid waste services to Village businesses. There will be further discussion at the next meeting for this topic. This is not a tax on the businesses in Quil Ceda Village but a tax on the solid waste collection businesses coming into serve the Village businesses. The fee helps offset the cost of maintaining the roads that the trucks travel over. The GM is requesting the tax so that all companies can be charged for the franchise fee. Section #7 will be revised/omitted. This is the first reading. The next reading will be in January and the resolution will be provided for February's meeting.
