4) Tulalip Police Department September Report

Discussion: Chief Chris Sutter, TPD, Cameron Reyes, Property Manager

During the month of September TPD conducted 40 traffic stops, responded to 27 suspicious vehicles, the stats for crimes against people show no remarkable changes. We are contacting the stores to prepare for Black Friday shopping. It sounds like many of the retailers will be spreading out their sales throughout the month of November to reduce the amount of shoppers. Property Manager, Cameron Reyes, asked if they have been working towards the RV parking outside of Walmart and other areas inside Quil ceda Village. Chief Sutter responds that the RV parking has always been a big issue and difficult to keep up with because officers will knock on their doors ask them to move and they'll drive to another spot.
