Quil Ceda Village is seeking services from Tulalip Bay Fire. Tulalip Commissioner explained they made staffing preparations to support services to Quil Ceda Village. Contract terms were discussed about specific services provided, invoicing and payment processing, and service area. Interim Chief Neuhoff explained to the Council that the Marysville Fire District as included services to Quil Ceda Village and the funding in their 2023 Operating Budget, and adjusting services would take time.

9) Tulalip Police Department Monthly Report

There were no major crimes within the Village during the month of October. Chief Sutter explains that there will be increased resources for loss prevention in the mall are for Black Friday. The Council asked if there were any regulations that could use updating to ensure that property crime arrests are enforceable and/or take legal action in court, and if hiring additional security is an option. Councilmember Shopbell says that Property Management will be hiring Property Management Security Guards in 2023. Chief Sutter announces additional officers will be onsite beginning November 18, to help control traffic for the event and signage will be in place.
