3) Marysville Fire District Monthly Report

During the month of November, there were 51 calls for service, 42 were EMS related and 14 resulted in transports. The average response time was 9 minutes 23 seconds. We hired 7 of the 8 full-time positions and

4) Tulalip Police Department Monthly Report

The first bar chart shows there was decrease in crimes against people, there was an increase in Property Crime, and no change in Vehicle Related incidents. Councilmember Shopbell asks Chief Sutter if officers ever makes stops and writes tickets. Chief Sutter responds by saying yes we do, as needed. Those traffic infractions are sent to Tulalip Tribal Court. The Lights & Ice event and begins explaining that there are extra officers on-site.

5) Monthly Finance Report

We are pretty close to pacing on budget. The cigarette taxes are at 85%, which is a touch low from what we budgeted for. For 2023, we budget for 7.5 million and that is likely where we will fall for 2022. The cannabis tax is the sales tax is at 80% right now. I think we have peaked and sales are steady. The motor fuel tax is 3.2 and will change next year due to our change in distributor. The various other taxes are at 66% of the year, and 2.4 will be expensed for Public Safety.
