5) Monthly Finance Report

The finance report is through May and 42% of the year. Cigarette tax income is the major source of income and is pacing a little below budget. We talked to Harbor today and that is the overall trend. The cannabis taxes are close to what we budgeted. The last one is the fuel tax and that is still about double of what we did last year at 2.5 million. We will pay the first half of the Public safety items, those are Office of Reservation Attorney, Court Services, Prosecutorial and Tulalip Police Department. The next one is the projects for the Village and the red items are the building items.
