3) Marysville Fire District Monthly Report

Chief Vander Pol stated that the monthly activity for June is within normal limits, the average response time was 10 minutes, 32 seconds. Marysville Fire responded to 5 incidents at Boom City -1 injury with burned legs, but nothing serious to report.

4) Tulalip Police Department Monthly Report

Chief Sutter provided a brief overview of the monthly statics and stated that calls for service are unremarkable and the next slide is the property crime. Trespass and report when agreed upon, it was trending lower due to not reporting. Traffic was down in June. I want to thank the leadership of the Village along with increased police force, it made for a much safer 4th. There were no major incidents similar to that of last year. The Council asked about the theft at the outlet mall and transient activity behind Walmart. Chief Sutter replied that much of the theft that occurs are groups of people that enter business and grab handfuls of merchandise and run. There is no minimum threshold for making arrests, but cannot make an arrest without retailers being willing to prosecute. As far as the homelessness, we do clear out the woods as often as we can. We have noticed brush fires occur, so when responses are made, and we make them move on. They are all offered social services, and more people refuse assistance than those that accept. The amount of homelessness has gone down since the Pallet Shelter has opened.
