President Fryberg announced the Tulalip Tribes and Quil Ceda Village has been working on a joint effort to expand the Tulalip Fire District 15 service area for roughly 10 years now, continued to state the importance of having fire and emergency services in the Village to protect the commercial assets and consumers visiting the Village. We are now prepared to move forward.

3) Christmas Lights Expansion Discussion

President Fryberg states that a request was received to expand the Christmas Lights display area be added to the agenda for discussion, the floor is now open for discussion. During the 2021-2022 holiday season, Tulalip Tribes received excellent feedback on the display, and was featured on several local news outlets. The news stories highlighted the lights displays and family activities onsite at Tulalip. There was a noticeable increase of traffic in the Village and the Tulalip Chairwoman expressed her support for the expansion of the lights display. The Council asked staff to reach out to the Tulalip Casino to discuss marking and planning for the upcoming holiday season. Marketing and Events announced that with this expansion there will be a total of 6 million LED lights displayed between the Tulalip Amphitheater, Tulalip Casino, Tulalip Bingo, and Quil Ceda Creek Casino from November 22, 2023 – January 15, 2024. The Council directed staff to prepare the Contract Amendment for approval at the October meeting.
