3) Tulalip Bay Fire District 15 Monthly Report

Tulalip Bay Fire is in the process of updating the fire suppression access and is continuing to work with the Marysville Fire District to balance the calls for service. The new ladder truck has shipped, it is an 85' foot trailer with a 125' ladder. When it arrives, we will need to shut down part of 27th Avenue. Tulalip Bay Fire Chief stated that he appreciates the opportunity to serve the Tulalip community, we have a young staff that is eager to learn.

5) Fee In-Lieu Program Update - Handout

The Fee in-lieu program is a credit-fee type program that impacts our wetlands. A fee is created per acre and the applicant pays that fee. After the fee is paid, it will be deposited into an account administered by Quil Ceda Village. Finance will create General Ledger accounts. General Manager Jones asked about Natural Resource projects are impacted by this program. Not all of the wetlands are managed by the Corps, some are managed by Tulalip Tribes Natural Resources. Lee Shannon mentioned the need to update the process due to recent Supreme Court decision on wetlands.
