3) Tulalip Fire District Monthly Report

Chief Shaughnessy provides an update for calls of service provided by Tulalip Bay Fire for the month of February, there were 114 total calls, 87 calls were outside of the Village and 33 calls within the Village. The dispatch issues have been adjusted, and we are trending in the right direction. The fire department provide

The Council asked Chief Shaughnessy about the additional costs to support services calls outside of the Village. Chief Shaughnessy replied that both Tulalip Fire and Getchell Fire Department have met with Marysville Fire Department to request reimbursement for some calls to service. Marysville Fire is understaffed and unable to support all the calls for service, so we are working on an inter-local agreement to help subsidize the costs for support outside our designated service area. Announcement: Tulalip Bay Fire will be hosting an event at the Tulalip Gathering Hall on March 21, 2024, for a Swearing-in and Badge Pinning Ceremony. This is specific to the team that was hired to service the Village.

4) Tulalip Police Department Monthly Report

Deputy Chief Gobin provided an overview of the February statistics by stating there is nothing significant to report and asks the Council to direct their attention to the Pro-active Patrol statistics. This report shows what the officers actively work on when not responding to calls for service. The Council asked about increased officer patrols to help improve public safety and guest shopping experiences. General Manager Jones replied that the Village, Seattle Premium Outlets, and the Tulalip Police Department are currently working on a joint project to improve public safety.

5) Monthly Finance Report

Tulalip Tribal Federal Corporation, Controller, Chris Schmidt provides the monthly finance report and explained that January saw a decrease in sales that impacted the income budget. After meeting with the Supply Chain team, it seems this trend in common this time of year. The income was budgeted aggressively. The Motor Fuel tax is pacing above budget. The Tulalip Liquor Store replacement project will be breaking ground soon, no exact date to report yet, but we may see a fluctuation in the sales of liquor and cigarettes during that time.
